I wish to enroll my child in the 2017 Chester Playhouse Summer Theatre School.

On behalf of my child, I accept responsibility for the terms and conditions below:

- 1) The school will operate July 24th – Aug 19th (four weeks) from 9:00 a.m. to 4:00 p.m., Monday to Friday and 2:00 p.m. to 9:00 p.m. during the performance week. Aug 14th - Aug 19th .
- 2) All youth aged 9-17 are welcome to apply. Students aged 9-11 will be required to meet and get approval from the Director
- 3) The fee for the school is \$450.00 payable as follows: a deposit of \$100 is required along with the completed registration form. Registration forms are due by July 1st. The remainder of the payment is due on or before July 24th . Bursary's are available through Pro Kids- Chester Recreation Department or through the Alexander Flemming Pattillo Foundation via the Playhouse
- 4) Meals, transportation and lodging are the responsibility of the participants.
- 5) Although we will exercise care in looking after your child, the Chester Theatre Council or their employees cannot be held liable for any injuries or loss involving your child.
- 6) Participants are expected to attend all rehearsals and performances. If an emergency were to occur, we must be informed of the absence of your child.

Please note the following:

- 1) The Chester Playhouse operates the Summer School off-site. The Facilities where the school is held requires a damage deposit and anticipate due care for buildings and property. By signing below, children and their parents agree to be respectful of the premise and property hosting our school and take responsibility for reimbursing the facility for damage caused.
- 2) Discipline shall be encouraged through positive reinforcement, clear direction and articulated choices. **An disrespect shown or bullying of any sort will not be tolerated.** Should misbehaviour continue after appropriate warnings, a child may be expelled from the school for a specific period of time or for the duration. Harmful or extreme behaviour may result in immediate expulsion.
- 3) At the end of each rehearsal day, students shall be released to the care of the responsible parent or other pre-authorized individual at 4:00 p.m. In the event that students are unable to be picked up by 4:00 p.m., the staff at the school will take students to the Chester Playhouse (22 Pleasant Street, Chester) where they will remain until transportation becomes available. During this time students are not under any direct supervision from any staff member of the Chester Playhouse.
